Training Schedule

2025

JANUARY – NIGHT SHOOT QUALIFICATION – RANGE 2 (2 HOURS)

January is the BOI's annual night shoot handgun qualification month. Investigators shoot in low-light or no light conditions. Investigators practice using flashlights or gun mounted lights while shooting as well. Investigators work on weapon manipulations in low-light or no light situations. This includes reloading of their weapons.

FEBRUARY – STRATEGIC COMMUNICATIONS (4 HOURS)

Investigators will receive online instruction on STRATEGIC COMMUNICATIONS. This is a POST mandated class.

MARCH – SHOOTING FROM BARRICADES – RANGE 2 (2 HOURS)

Investigators shoot their weapons from a static line position, followed by shooting from a barricaded position. Investigators will shoot from the left and right sides of the barricade. Investigators will shoot their weapons using their "weak" or "support" hand.

APRIL – BATON (2 HOURS)

Investigators will receive baton training.

MAY – WEAPON INSPECTIONS / QUALIFICATIONS – RANGE 2 (2 HOURS)

Range instructors conduct an annual inspection of all issued weapons. Investigators will complete a qualification course for their issued duty weapons.

JUNE – POST MANDATED EVOC / DRIVERS TRAINING – FPD FACILITY – (4 HOURS)

Investigators must complete a POST designated slow and high speed driving course. Instruction is provided by POST certified Driver Training Instructors.

JULY – BACK-UP / OFF-DUTY WEAPONS QUALIFICATIONS – RANGE 2 (2 HOURS)

Investigators are required by policy to shoot and qualify with their back-up/off-duty weapons if different than their duty weapons. This is done annually.

AUGUST – SHOTGUN TRAINING / CLEANING OF SHOTGUNS – RANGE 2 (2 HOURS)

Investigators will shoot a shotgun qualification course. Investigators will shoot both double 00 buckshot and slug ammunition.

SEPTEMBER – POST MANDATED TACTICAL FIREARMS TRAINING – RANGE 2 (4 HOURS)

Investigators receive four hours of classroom lecture and outdoor firearms training that is mandated by POST.

OCTOBER – MAKE UPS – RANGE 2 (2 HOURS)

October is our make up month. Investigators who missed range training, specifically PSP mandated firearms training, will come to the range to complete their training for the month.

NOVEMBER – FIREARMS QUALIFICATION – RANGE 2 (2 HOURS)

Investigators will shoot a handgun qualification course.
